- Important Notes :**
1. The total number of section of the school shall be restricted to 23 (as per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
  2. The school has shown ramps at a number of entrances. However they are not on level ground and damaged (at the school gate) and don't have hand rails. Further the 2 ramps other than the main gate lead to rooms/galleries with raised platforms, which would be a barrier to easy navigation by CWSN. Such raised platforms/ door frames are seen at every door step. The school shall level the door steps to ensure smooth access to CWSN and re construct the ramps at the entrances with proper incline and safety features as prescribed in RPWD Act and submit compliance on SARAS portal within 3 months.
  3. The school is directed to construct the partition in the boys urinals within 3 months and submit the compliance on SARAS portal
  4. The school shall ensure training of its teachers with CoE Chennai within 3 months and submit the compliance.
  5. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
  6. The school shall get all the mandatory certificates renewed periodically.
  7. The school shall not remove the videography links in the mandatory disclosure section of its website
